Qualification Period: 1st March 2011 to 31st January 2012

QUALIFICATION REQUIRES 800 CREDITS

The CEME 2012 qualification period runs from 1st March to 31st January 2012.

To qualify for CEME 2012 you must achieve a total of 800 credits over any six consecutive months during the qualification period. For example, March to August or August 2011 to January 2012.

QUALIFICATION FOR ALL RANKS

100 credits will be awarded for every 1st level Qualified New Manager (Over your Manager Base) during the qualification period, and for every month they qualify as a Manager.

If a new *Manager breaks out of your Group Volume and is not blocked by any ranked Managers, you will receive 100 credits, providing you are a qualified Manager or higher.

- At least one Manager used must be qualified at rank in the last qualifying month in order to qualify for this convention.
- Your business must have no decrease in TOV during your qualifying 6 month period, when compared to the same consecutive 6 month period in the previous year.
- You must be ranked at Senior Manager or above to qualify to attend this convention.

**Managers who qualified during the two-month period prior to the start date for qualification can be used towards your qualification. However, no credits will be awarded for activity before the qualification start date. These Managers can only be counted if they have not already been used towards a previous convention.*

MANAGER BASE

New Distributors: Sponsor a new Manager and this will count towards credits for your qualification. You must be ranked as Senior Manager by the end of the qualification period in order to attend.

Executive Managers and above: Your Base Managers have been calculated using your average monthly Qualified Manager count during August 2009 to December 2009. Any new Managers above the base requirement will be counted towards the qualification.

Please note that the minimum base requirement is three qualified Managers. For each convention you qualify for, one additional Manager will be added to your Base Manager Requirement.

560 Rule: Credits will be halved if you break out a new Manager using the 'New Manager' rule. You must be a ranked Manager and have a Group Volume of 1120 or more to receive the full amount of credits.

ALTERNATIVE QUALIFICATION FOR EUROPEAN DIRECTORS AND ABOVE

You will need to help three Distributors from no less than two separate legs achieve the trip by meeting the Qualification Criteria. The first qualified distributor; at the rank of Senior Manager or above; in a business leg that has qualified to attend will count, and will also block all qualified Distributors below that person.

You will be required to show no drop in TOV compared to the same period in the previous year. Distributors used to qualify for this convention can not be used towards TAC. Your Manager Base must be achieved at least three times during the qualification period, March 2011 - Jan 2012.

Terms & Conditions Apply: Named account holders only, or a manager that has helped you to achieve the criteria, may attend. At least one named account holder must attend in order to take a manager who has helped them to achieve the criteria. Moving of PGV to create new managers is not allowed and will be monitored. Tickets are not transferrable, and may not be exchanged for attendance at any other convention. If you are unable to attend the convention you may not transfer to attend the next one. The date and location of the Convention may be subject to change. There is no cash alternative. The Managements decision is final. Please Note: We must receive your completed Registration Form in order for you to obtain credits.
